- Fire Department

 - They are getting bids for the blacktop replacement in the hose washing area of the parking lot.
- Roads
 - The Stadt Road approach south of H was repaired and a ditch was dug to the divert water from running across the road
 - Shortt Lane turn-around installation was completed
 - o Mill Creek Bridge replacement start date was changed to September 15 and the McMillan Creek bridge will start approximately 1 week later with an anticipated completion date of November 14th. The town will receive notice 1 week before project start date. The current replacement estimate for both bridges is \$820,870.55.
 - o After discussion about roads <u>Motion Weigel/2nd Gukenberger to put an additional 3-4" of road base on South Rondivoo later this year and to contract with Wood County to do the grading.</u> Motion carried 3-0.
